PRE-QUALIFICATION - WEST POKOT COUNTY GOVERNMENT

PREAMBLE

The County Government of WEST POKOT is one of 47 County Governments in Kenya.

It is out to execute its vision and mission within its area of jurisdiction. The Institution is mandated to execute service delivery in Road construction, Rehabilitation & Maintain ace contributing to economic development particularly in rural areas.

WEST POKOT COUNTY GOVERNMENT intends to prequalify applicants for the provision of **HIRE OF EQUIPMENT** for financial year The purpose of this pre-qualification exercise is to competitively identify contractors to be included in a shortlist of suitable contractors register capable of providing the said services to **the COUNTY GOVERNMENT OF WEST POKOT.**

The pre-qualified contractors shall be invited to submit bids as appropriate. This exercise and the subsequent tendering processes shall be subject to the Kenyan Public Procurement and Asset Disposal Act 2015 and all governing Regulations.

The standard document includes a form for invitation for prequalification, instructions to candidates and a letter of application with attached forms for candidates to complete.

SECTION I - INVITATION FOR PRE-QUALIFICATION

County Government of WEST POKOT (hereinafter referred as “Procuring Entity”) intends to prequalify applicants for the provision of EQUIPMENT FOR HIRE on “**as and when required basis**” for period ending June 30th 2017:-

2.1 Eligible Applicants

- 2.1.2 All the information requested for pre-qualification shall be provided in the English Language.
- 2.1.3 Failure to provide information that is essential for effective evaluation of the applicant's qualification or to provide timely clarification or sub substantiation of the information supplied may result in the applicant's disqualification.
- 2.1.4 This Invitation for Bids is open to all eligible contractors under category G (Hire of Equipment for Road works).
- 2.1.5 Bidders must not be under a declaration of suspension for corrupt, fraudulent, collusive, coercive or obstructive practices as issued by the Kenya government.

3.1 Qualification Criteria

- 3.1.1 Pre-qualification will be based on meeting the minimum requirements to pass in the criteria for the various categories as set out in the Appendix 1 hereof.
- 3.1.3 Contractors who qualify according to the selection criteria will be invited on "as and when required basis".
- 3.1.4 Pre-qualified contractors whose qualification are accepted by the County Government of WEST POKOT after meeting the evaluation Criteria will utilize the standard rates approved by the County Tender Committee for the FY.
- 3.1.5 For the purpose of Sec 39(4)(c) of the Act exclusive preference shall be given to local contractors based and operating in the region except where it is established that local capacity is not available.
